President's Message: Dr. Toone reported four people have resigned – Daniel Cyre, David Guiboa, Amanda Macoby and Patrick Sieben.

Vice Presidents' Reports:

Vice President for Student Affairs and Advancement Kim Reynolds reported Shawn Walden and people from Dynamic Campus have helped Admissions with the enrollment process. There have been more than twice as many visits and applications this year compared to last. Enrollment days have been established. The Foundation auction is April 1. Last year 285 tickets were sold, this year 329. In athletics, softball, baseball, track and field seasons have started.

Vice President for Academic Affairs Brenda Edleston reported they are working on 2+2 articulation agreements with four-year universities. The policies with Military Occupation Specialty codes (MOS) are on the Kansas Board of Regents website. Our Performance Agreements were approved, and we will be funded at 100%. Induction into Phi Theta Kappa was held. Aggie Days was held today with 23 high schools and over 300 students. The Art Show is April 7. The Band and Choir concert is April 27. Several activities have been held at the Geary County Campus.

Vice President for Administrative Services Amy Lange reported February, March and April are the months where we have contract renewals and bidding processes. The Maintenance team began the renovation of the new Nursing classroom last week. The last couple of weeks she attended two conferences. April 25 will be the campus beautification day.

Vice President for Information Technology Shawn Walden reported they worked on Financial Aid work processes focusing on credit hour update and automated packaging. They are working on Letters of Intent, transcript evaluation, student refunding and all the processes of enrollment management. A power outage last Saturday outlasted our battery backup, and the IT staff have spent many hours working on bringing everything back up.
