Performance Agreements have been submitted. We met every category except one, and are eligible for 100% of any new funding out there. They are now at the State for approval.

Vice President for Administrative Services Amber Knoettgen said the budget is complete and is out there. We received the first half of the State Operating Grant, and it was more than we expected. The auditors will be here the week of September 10. The cafeteria is near completion. There is great feedback from the students. She is working with USD 333 on signage for the track. Our next project will be the athletic training room and locker rooms. IT is replacing the computers. They are working on a shared drive for Board of Trustees minutes, Cabinet minutes, etc. A new Application for Admissions is almost complete. Dynamic Campus is pulling together all the items for next year. Shawn Walden will talk with IT on Thursday to finalize the items.
